Radical Peasants, Land Reforms and Squats: A Global History

Between 1890 and 1980, movements for freezing rents and redistributing large-scale farms transformed property law in almost every nation in the world. In the form of the Via Campesina, Ekta Parishad, global land movements constitute the most numerous political movement around the globe today. Their contentions over the relationship between justice, land ownership, housing, and water constitute one of the most coherent grounds for global governance of the environment today.

In learning about these movements, students will read of key documents from western and non-western rent strikes, advocates of land invasion, global governance, and liberation theology, gaining acquaintance with key events and authors. Exercises will involve using digital tools to analyze World Bank reports, delving into primary-source documents from the global history of urban squatting, and independent research on a related topic of the student's own choosing.

Assessment and Why it Happens

In addition to a final research paper, this course requires students to participate in another major exercise in digital history that involves analyzing a large trove of electronic documents from one of the institutions involved in global land reform with the help of a computer-driven algorithm called "Paper Machines."

It is hoped that by participating in the creation of knowledge, students may gain a wider and more critical view into the making of expertise, the labor it requires, its uses, strengths, and limits.

A small number of supplementary assignments are designed to adequately prepare students for the task of writing a major history research paper.

Finally, active involvement in class discussions is expected, and time will be set aside in the course of every meeting for dialogic engagement with the themes of the course.

Students' final grades will be determined as follows:

Final Paper (40%) Collaborative Digital assignment (25%)

Other short assignments (18%; 3% each) Participation (17%)

- 1909 Molina Enriquez calls for land reform in Mexico
- 1910 Zapata helps Madero overthrow landlord president Diaz in the Mexican Revolution
- 1911 Zapata drafts Plan of Ayala
- 1915 Agrarian Decree in Mexico promises land for those in need
- 1917 New constitution of Mexico recognizes idea of the Ejido
- 1934 Mexico redistributes 4 mil acres of American property
- 1940 Ejidos Privatized in Mexico
- 1970 "land reform is dead" in Mexico
- 1991 NAFTA makes life hard for the remaining ejidos in Mexico by forcing President Carlos Salinas de Gortari to eliminate the constitutional right to ejidos.

Week 4: The Cultural Revolution in China. Are collectives or private landowning more productive? Which is more secure? Which are better? – Th Sep 25

1946-1953 - Chinese Land Reform on the basis of Family Farming

1953-6 – Maoist land redistribution begins in North Vietnam. Between 50,000 and 172,000 "class enemies" are executed.

1955 - Chinese Land Reform becomes collective farming, more productive than family farming

1958 - China makes it illegal for individuals to withdraw from a collective

1959-61 – 30 million Chinese die as a result of an agricultural crisis

1968 - In Operation TAKEOFF, the United States plans on using demonstrations of rice strain IR-8 to convert peasants in Vietnam to Capitalism

1970 - China independently inaugurates its own green revolution - more productive rice

1970-5 – a scholarly debate erupts between Edwin Moise, Gareth Porter, and Robert F. Turner arguing over the number of people killed in relation to land reform; some relying on communist sources, others criticizing those sources as a source of bias.

Week 5: The Rise and Emasculation of the United Nations – Th Oct 2

- 1941 American President F. D. Roosevelt declares "Freedom from Hunger" as one of the "Four Freedoms" that should drive international policy in an Americanled world
- 1943 Food and Agriculture Organization of the United Nations is founded with John Boyd Orr of Britain as its director
- 1948 Parsons recommends land reform by courts, market, willing buyer and willing seller, on basis of "stability" (United States)
- 1951 The University of Wisconsin organizes an international conference of experts on land reform
- 1958 Cooperatives, land ceilings, distribution in Egypt w revolution
- 1958 Land Reform begins in Cuba
- 1961 American President John F Kennedy announces land reform as a basic agenda for US intervention in Latin America at the Alliance for Progress meeting in Punta del Este, Uraguay
- 1966 World Land Reform Conference (United Nations)
- 1971 CGIAR founded to promote green revolution across NGOs, starts agricultural gene bank (United States)
- 1972 FAO influence begins to wane with the rise of the World Bank
- 1976 The United Nations Conference on Human Settlements releases the Vancouver Action Plan, whose, 64 recommendations for National Action, whose fourth chapter (of six) is on land ownership and whose fifth is on "public participation"
- 1978 the impotent FAO organizes the WCARRD conference, predecessor to declaring the international rights of peasants to maintain control over their own land
- 1989 FAO declares seeds a "common heritage" but fails to establish rights for farmers to protect their seeds from enclosure (United Nations)
- 1997 United Nations begins a program called Grassroots Movements and Initiatives for Land Reform to document best cases

Week 6: Right-Wing Regimes Planned Counterrevolutions in Chile, Guatemala, Nicaragua, Iran – Th Oct 9

1936 - In Bolivia, Brazil, Chile, and Colombia, the rural poor gain the franchise and land reform follows

1948 - In Ecuador, Guatemala, and Venezuela, land reforms accompanied the removal of voting proscriptions

1951 - Guzman wins election in Guatemala based on land reform platform designed to limit power of United Fruit

Week 7: Food Crisis or Housing Crisis? - Th Oct 16

1974 - UN World Food Conference in Rome recommends the adoption of an International Undertaking on World Food Security (United Nations) 1980-90 - low prices for food leads to the slashing of tariffs in the global south, encouraged by the IMF

1987 - "Sustainable Development" is defined as an agenda by the UN in The World Commission on Environment and Development's report, Our Common Future, commonly called the Brundtland Report, named for Norwegian prime minister Gro Brudntland, leader of the commission.

2002 - Venezuela grants property titles to squatters

2004 - Anuradha Mittal founds the Oakland Institute to document world food security and land rights issues

2005-10 - unprecedented food prices lead to a new era of famine

2008 – GRAIN, an NGO in Barcelona, documents an international land grab staged by financial institutions with the ostensible goal of providing food security 2010 – NYU law report calls for the protection of human rights in the midst of an international land grab

Week 8: Radical Land Reform in India: Operation Barga to Ekta Parishad - Th Oct 23

- 1951 Bhoodan or Land Gift Movement inaugurated by Vinoba Bhaveat Pochampally village
- 1957 Kerala Land Reforms Act forms new State Land Board (India)
- 1958 Land ceilings in Kerala
- 1969 Sarva Seva (India) helps landless Bhoodan recipients become more productive
- 1970 Raj and Sen define the Kerala model of participatory politics, land reform, etc.
- 1978 Operation Barga begins to register sharecroppers in Bengal
- 1990 a UN study finds that Kerala is awesome, land reform worked
- 1991 Ekta Parishad founded to lobby for land and forest rights (India)
- 1992 A national seminar on land reform in India reviews fifty years of progress and concludes that land ceilings and tenant rights increase democratic participation, agricultural development, and non-subsidized land and water management
- 2004 Janadesh 2007 campaign organizes 25,000 landless peasants marching across India
- 2009 Sindh Peasants March demands tenants rights (Pakistan/India)
- 2011- Ekta Parishad plans an enormous march of the landless demanding reforms
- 2012 Jansatyagraha 2012 march of the landless (India)

Week 9: Radical Land Rebellion from Below in Latin American: Brazil, Bolivia, Venezuela, Peru and Colombia – Th Oct 30

1928 - Mariategui identifies the "Indian Problem" in Peru as a subset of the "Land Problem"

1945-6 Organization of unions into the Fderacion Campesino (FCV) under Ramon Quijada in Venezuela (South America)

1948 - In Ecuador, Guatemala, and Venezuela, land reforms accompanied the removal of voting proscriptions

1952 - Bolivian Revolution brings land redistribution (South America)

1952 - Experiments with Quechua Indians and breaking up a hacienda in Peru (South America)

1958 - with the collapse of Jimenez's dictatorship, lands in Venezuela formerly opened up under the Accion Democratica government are again spontaneously invaded by local campesino leaders

1959 - Battle of Chavez Ravine, Los Angeles

1960 - Agrarian Reform Law in Venezuela leads to rapid land reform measures supervised by the National Agrarian Institute (Instituto Agrario Nacional)

1960-4 - In Brazil, the Peasant Leagues lead a land reform movement whose goals are eventually embraced by president Joao Goulart and then the dictatorship.

1960-70 The Brazilian military attempted an auspicious reform in the 1960s, but did not significantly redistribute land.

1961 - Allying w/ Kennedy's Alliance for Progress, Latin American countries vow, in the Declaration of Punta del Este, to encourage "programs of comprehensive agrarian reform"

1964- The Ecuadorian military eliminated virtual serfdom in 1964 and eventually expropriated over 15 percent of Ecuador's farmland.

1964 - Brazilian president Goulart proposes land ceilings and is deposed because of them

1964 - Freire exiled from Brazil by new rightwing military regime, moves to Peru

1969 - The Peruvian military embarked on a massive land reform program in

1969 that expropriated over 40 percent of the country's agricultural land and distributed land to more than one-third of rural families.

1972-3 United Front for Land Reform formed in Ecuador, organizes mass marches (South America)

1984 - MST organized for land reform in Brazil

1985 - Brazil's first National Plan of Land Reform in 1985 splits peasant and bougeois land planning, giving weight to the MST

1997 – 50,000 show up for MST Protest in Brasilia

2000 - Explosion of MST: 30,000 rural workers occupy 250 latifundios

2001 - first World Social Forum gathers counter-hegemonic organizations in Brazil

2001 - Plan Zamora brings land reform to Venezuela

1978 – The Grameen Bank is at work in India

1982 - NABARD founded to provide credit to rural areas in India

1983 - PRADAN (India) links banks w/ NGOs for rural poor

1989 - the Farm Law (Taluseadus) of 1989. This law was the Estonian Soviet Socialist Republic's first nationwide step away from collectivisation towards the re-creation offamily farms, and its provisions have to be understood in the context of Soviet rule which continued formally until Independence in 1991.

1985- rise of SHGs -- self-help groups – microfinance

1991 - privatization reform in Romania

1992 - United States Supreme Court establishes precedent for total reimbursement after state property regulation in Lucas v South Carolina, upholding property rights against environmental regulation

1992 - NABARD begins the SHG Bank Linkage Program with 500 SHGs (Microfinance, India)

1996 - CAPRi established within CGIAR with aim of fixing individual property rights in the developing world

1996 - FAO's RuralInvest develops from spreadsheets on applicants, proposed activity, income, management, to recruit microinvestment. Later they will issue open access software.

1996 - Georgian Landowners' Association organizes for landlord rights/privatization (Eastern Europe)

1999 - USAID and the World Bank create a land market in Kyrgyzstan

2003 - Mugabe becomes a case study for CATO to argue that land reform produces violence, dictatorship, and environmental disaster (United States)

1932 – The British Land Commission in Kenya begins taking evidence of how far indigenous people are owed compensation for seized land 1952-60 Mau Mau rebellion in Kenya

1954- Swynnerton Plan allows native Africans to hold private land in Kenya for first time

1963- Kenya began to breakup common lands into group ranches

1968 - Kenya organizes Masaai herders into group ranches (Africa) w/ help from USAID
